

AGREEMENT SECOND ADDENDUM

THIS SECOND AMENDING AGREEMENT dated March 22, 2023 between: Sun Radiology, P.C. – AND – Einstein’s Brain and Pain LLC has an effective date of **January 26, 2023.**

Background

A. Sun Radiology, P.C. and Einstein’s Brain and Pain LLC (the “Parties”) entered into the accounts receivable purchase agreement (the “Agreement”) by mutual signature on January 26, 2023, being effective on that date, and first amending agreement by mutual signature on March 19, 2023, for the purpose of “to provide, through qualified health care providers, technicians, diagnostic imaging and board-certified radiologist reads (reports) and related imaging services (the “Services”)”.

B. The Parties wish to amend the Agreement Addendum on the terms and conditions set forth in this Second Amending Agreement (the “Second Amending Agreement”).

C. This Second Amending Agreement is the second (“2nd”) amendment to the Agreement.

D. References in this Second Amending Agreement are to the Agreement Addendum mutually signed on March 19, 2023.

IN CONSIDERATION OF the Parties agreeing to amend their obligations in the existing Agreement, and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree to keep, perform, and fulfill the promises, conditions and agreements below:

Amendments

1. The Agreement is amended as follows:
 - a) Exhibit A – version 3 fee schedule attached hereto.
 - b) In consideration of each Accounts Receivable assigned to Einstein’s Brain and Pain LLC (“EBP”) hereunder, EBP shall pay to Provider an amount equal to three hundred fifty dollars (“\$350.00”) for each spinal and extremity MRI study and report performed at Provider’s locations. EBP shall pay to Provider an amount equal to six hundred dollars (“\$600.00”) for each brain MRI with TBI protocol study and report. EBP shall pay to Provider an amount equal to two hundred seventy five dollars (\$275.00) for each CT of the spine per spinal region

study and report, EBP shall pay to Provider an amount equal to seventy-five dollars (\$75.00) for each X-RAY of the spine per spinal region study and report performed at Provider's locations.

No Other Change

2. Except as otherwise expressly provided in this Second Amending Agreement, all of the terms and conditions of the Agreement remain unchanged and in full force and effect.

Miscellaneous Terms

3. Capitalized terms not otherwise defined in this Agreement will have the meanings ascribed to them in the Agreement. Headings are inserted for the convenience of the Parties only and are not to be considered when interpreting this Second Amending Agreement. Words in the singular mean and include the plural and vice versa. Words in the masculine include the feminine and vice versa. No regard for gender is intended by the language in this Second Amending Agreement.


Governing Law

4. Subject to the terms of the Agreement, it is the intention of the Parties that this Second Amending Agreement, shall be governed by, and shall be construed, interpreted, and enforced in accordance with the laws of the state of Arizona.
